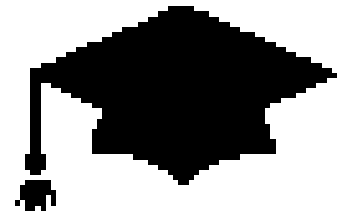

To Qualify, You Must:

Janet Keady was the mother of four Pleasant Valley High School graduates. As a parent she was a great proponent of our school and proud of our academic reputation. Mrs. Keady wanted to help deserving students with strong scholastic accomplishments and financial need by creating a scholarship for use in public postsecondary education. Her belief that financial need not be a deterrent for a bright, hardworking student's college aspirations was a driving force in creating her memorial scholarship. Janet Keady lived a very short life after a courageous battle with cancer, but has had a long-lasting impact on the many lives her scholarship has touched.

***Be a senior at PVCHS.**

***Submit a transcript of credits reflecting seven semesters of work.**

***Plan to attend a college or vocational school upon graduation.**

***The scholarship is a tuition scholarship and will be paid directly to the institution.**

***A personal interview will be required for finalists.**

***The scholarship will be granted for one year and is non-renewable.**

***Selection will be based on academic accomplishment, participation in extra-curricular activities, and demonstrated financial need.**

***This scholarship is designated for students who plan to attend those schools whose cost are in line with/or less than the regents institutions in Iowa.**

Make application and return to the principal by March 2, 2009.

The Janet E. Keady Memorial Scholarship is self-perpetuating from a non-profit trust fund established by the family in 1990. The scholarship is funded by interest income generated by the trust. It is projected that the minimum amount of the scholarship will be \$1000.00 annually.

The scholarship recipient will be determined by a scholarship committee composed of the following persons:

- *High School Principal**
- *High School Associate Principal**
- *High School Activities Director**
- *A Guidance Counselor**
- *A Representative of the Keady Family**

The scholarship is open to Pleasant Valley Community High School seniors who have demonstrated academic excellence, participated in extra-curricular activities, demonstrated financial need, and who plan to continue their education after high school. The scholarship is for tuition only and will be paid directly to the institution that the recipient attends. The scholarship is non-renewable. Should the scholarship committee decide that there are no eligible recipients in a given year, the interest income for that year will be re-invested and will carry over to the following year.

Eligible students must make application to the principal of Pleasant Valley Community High School by March 3 of the year of their graduation. Application forms will be available in the guidance office at the high school. A personal interview will be required. The scholarship will be presented to the recipient at the Senior Awards Program held prior to commencement. A memorial plaque listing the scholarship recipients will be displayed permanently at the high school.
